Coach Kathy Graham gave a speech and included that this National Championship was a result of all Ranger College from the Board members to the students. These men and women lost half of the season due to Covid restrictions, but they went to lowa and competed to win. They worked the plan perfectly and the team proved themselves to be better than their competitors. The women's team won by 1 point at 75 points and Cloud County came in second at 76. The students ran on average a minute faster per mile than their standard. She then introduced the women's team. Coach Graham then introduced the men's cross-country team. She concluded with presenting the trophy to Dr. Campion and the Board as a gift.
