**EDUCATIONAL BENEFITS**

Tuition will be waived for full-time employees desiring to take courses at Ranger College. Faculty will be allowed to take up to 4 semester hours of credit per semester.

These courses must be taken outside their normal working hours.

The spouse, children, step-children, and adopted children will also be able to attend Ranger College on a full-time basis with all tuition waived. If the spouse or child receives a Pell Grant, then that Grant is applied prior to family member benefits for tuition.

All books and fees for these courses are not waived and will need to be paid.

**Application for Waived Tuition must be made at the Financial Aid Office prior to registration for classes. A minimum grade point average of a 2.0 must be maintained in all classes attempted before additional waived tuition will be approved.**
