A tax rate of \$0.286133 per \$100 valuation has been proposed by the governing body of Ranger College.

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for Ranger College from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that Ranger College may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Ranger College is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 28, 2023 AT 6:00 PM AT Ranger College Goleman Library Board Room.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Ranger College is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Regents of Ranger College at their offices or by attending the public hearing mentioned above.
