VN PROGRAM REQUIREMENTS

August to August Program

1. **Apply to RANGER COLLEGE online**, if not already a Ranger student. All guidelines for acceptance into Ranger College must be met. <http://www.rangercollege.edu/student-services/admissions/>
2. **Official Transcripts to Nursing Program** (no Ranger official needed)
 - Ranger College, 1100 College Circle, Ranger, Texas 76470
3. **Admission Test for Ranger College:** The Texas Success Initiative (TSI) assesses entry level academic readiness for college. Fee: \$30
4. **Register for the pre-requisite course (when available): HITT 1205 Medical Terminology: You must pass this course with a “C” or above.**
5. **Admission Test for Nursing:** The Test of Essential Academic Skill (TEAS) assesses entry level academic readiness of nursing program applicants.

 - b. Right top of page: Go to: CREATE AN ACCOUNT
 - c. Once your account is created, sign back into the account.
 - d. Right top of page: Go to - ONLINE STORE
 - e. (Next page) Left side of page: Go to TEAS
 - f. Drop down box:

 - TEAS - PN

6. **Apply to NURSING PROGRAM** - Obtain and complete a Nursing Program Application Packet (application, physical exam form, reference form)
 - a. Vocational Nursing Application
 - b. Reference Form (3)
 - c. Physical Exam Form
 - d. Vocational Nursing Requirements: Immunizations, CPR,

Application Packet Submission Deadline: May 15th for August admission.

Once the application packet has been reviewed by the VN Faculty, the following steps complete the process:

1. Director of VN Program will contact you to schedule a peer interview
2. Acceptance/denial letters will be mailed to applicants within 7 days after the interview
3. If accepted, your information will be sent to the Texas Board of Nursing
4. The TX BON will send instructions regarding your Criminal Background Check
5. The Director of VN Program will notify you when to schedule your Drug Screen.

ALL ACCEPTANCES TO THE VOCATIONAL NURSING PROGRAM ARE CONTINGENT ON COMPLETION OF THE PREREQUISITE COURSE, CRIMINAL HISTORY AND DRUG SCREENING.
